#### **NOTICE OF PROPOSED AMENDMENTS/MATERIAL ALTERATIONS TO THE DRAFT MAYO COUNTY DEVELOPMENT PLAN 2014-2020**

Notice is hereby given that in pursuance of the provisions of the above legislation, Mayo County Council has proposed to make amendments/material alterations to the Draft of the proposed Mayo County Development Plan 2014 – 2020.

**The Draft Plan incorporates AREA PLANS with detailed LAND USE ZONING and other objectives for the towns of BALLINROBE, BALLYHAUNIS, BELMULLET, CLAREMORRIS, CHARLESTOWN, KILLALA, KILTIMAGH, KNOCK, LOUISBURGH, NEWPORT AND SWINFORD.**

The planning authority determined that a strategic environmental assessment and an appropriate assessment were required to be carried out as respects one or more than one of the proposed material alterations to the Draft Plan.

A copy of the proposed amendments/material alteration to the Draft Plan, the Determination made in accordance with Section 12 (7)(aa), information on the likely significant effects on the environment of implementing the proposed amendment as set out in the SEA Environmental Report Addendum No. 1 and the Natura Impact Report Addendum No. 1 may be inspected along with the Strategic Flood Risk Assessment (as amended) from Wednesday 15<sup>th</sup> January 2014 until Thursday 13<sup>th</sup> February 2014 during normal opening hours at the following locations:

- The Planning Office, Mayo County Council, Aras an Chontae, The Mall, Castlebar;
- Ballina Civic Offices, Arran Place, Ballina;
- Castlebar Town Council Offices, Marsh House, Castlebar;
- Westport Civic Offices, Altamount Street, Westport;
- Mayo County Council offices in Ballinrobe, Belmullet, Claremorris and Swinford.

Any written submissions made to the Planning Authority during the period from 15<sup>th</sup> January 2014 to 13<sup>th</sup> February 2014 with respect to the proposed amendments/material alterations to the Draft of the Development Plan or the Strategic Environmental Report on the likely effects on the Environment of implementing the proposed amendments, will be taken into consideration before making the Development Plan.
