**SUPPLEMENTARY DEVELOPMENT CONTRIBUTION SCHEME 2009**

**As Adopted 9<sup>th</sup> March 2009**

**Mayo County Council**  
**Supplementary Development Contribution Scheme 2009**

**1. Introduction.**

This Supplementary Development Contribution Scheme is made pursuant to Section 49 of the Planning and Development Acts 2000-2006, and indicates the financial contributions, which Mayo County Council may include as conditions of planning permission in respect of public infrastructure and facilities benefiting development in the area which Mayo County Council have already provided or that it is intended to be provided by or on behalf of Mayo County Council.

**2. Nature and extent of the Supplementary Development Contribution Scheme.**

2.1. The Supplementary Development Contribution Scheme applies to the following categories of "**public infrastructure and facilities**" as defined in Section 49 of the Planning & Development Acts 2000-2006 :-

- (a) *the provision of particular rail, light rail or other public transport infrastructure, including car parks and other ancillary development,*
- (b) *the provision of particular new roads,*
- (c) *the provision of particular new sewers, wastewater and water treatment facilities, drains or watermains and ancillary infrastructure.*

2.2. The Supplementary Development Contribution Scheme indicates the amount of contribution to be paid in respect of different classes of public infrastructure and facilities that are provided or are to be provided by Mayo County Council.

In determining the amount of contribution Mayo County Council has had regard to the actual estimated cost of providing the classes of specific infrastructure and facilities.

2.3. The Supplementary Development Contribution Scheme includes a statement of the basis for determination of the contributions in column 4 of Schedules 1 and 2.

2.4. The Supplementary Development Contribution Scheme **may** allow for the payment of a reduced contribution or no contribution in certain circumstances in accordance with the provisions of the Scheme.

2.5. The planning authority shall not require the payment of a supplementary development contribution in respect of a public infrastructure project or service where the person concerned has made a contribution under Development Contributions Scheme made under Section 48 in respect of public infrastructure and facilities of which the said public infrastructure project or service constituted a part.

2.6. The Supplementary Development Contribution Scheme shall apply to the following areas within the functional area of Mayo County Council:-

- (i) **the West Region** comprising the electoral areas of Westport and Belmullet, and Westport Town Council
- (ii) **the South East Region** comprising the electoral areas of Castlebar, Claremorris and Ballinrobe and Castlebar Town Council;
- (iii) **the North East Region** comprising the electoral areas of Ballina, Swinford and Ballina Town Council.

the public infrastructure projects to which this Supplementary Development Contribution Scheme relates are set out in Schedules 1 and 2.

**3. Appeal of Supplementary Development Contributions.**

- 3.1 No appeal shall lie to An Bord Pleanála in relation to a condition requiring a contribution to be paid in accordance with the Supplementary Development Contribution Scheme.
- 3.2. An appeal may be brought to the Board where an applicant for permission considers that the terms of the Scheme have not been properly applied in respect of any condition laid down by the Planning Authority.

**4. Reduced Contribution.**

- 4.1. Mayo County Council, at its own and absolute discretion, **may** allow the payment of a reduced contribution where the payment of the contribution would not be just and reasonable having regard to any of the following -
  - (a) *the limited extent of the development,*
  - (b) *the limited cost of the development,*
  - (c) *other exceptional considerations.*
- 4.2.1. The amount payable for any reduced contribution under this section shall be not less than one quarter of the amount indicated in column 3 of Schedules 1 and 2 opposite the mention of the relevant class of the contribution in column 1.
- 4.3. A decision to allow a reduced contribution under this section of the Supplementary Development Contribution Scheme shall contain a statement specifying the reasons for the decision.

**5. Waiver of Contribution.**

- 5.1. Mayo County Council, at its own and absolute discretion **may** waive any contribution payable in respect of any particular planning application where it is satisfied that the development to be carried out by or on behalf of a voluntary organisation, and which in the opinion of Mayo County Council is :-

*(a) designed or intended to be used for social, recreational, educational or religious purposes by the inhabitants of a locality, or by people of a particular group or religious denomination, and is not to be used mainly for profit or gain,*  
*(b) is designed or intended to be used as a work-shop, training facility, hostel or other accommodation for persons with disabilities and is not to be used mainly for profit or gain, or*  
*(c) is ancillary to the development referred to in paragraph (a) or (b)*  
*(d) social housing units, including those which are provided in accordance with an agreement made under Part V of the Act (as amended under the Planning & Development (Amendment) Act, 2002) or which are provided by a voluntary or co-operative housing body, which is recognised as such by the Council.*

- 5.2. A decision to waive a contribution under this section of the Supplementary Development Contribution Scheme shall contain a statement specifying the reasons for the decision.

**6. Indexation of Contributions.**

- 6.1. The amount of contribution payable indicated in column 3 of Schedules 1 and 2 of this Supplementary Development Contribution Scheme shall increase in accordance with the Wholesale Price Index for Building and Construction in January of each year from the date of grant of permission up to the date that payment is made to Mayo County Council.

**7. Review of the Supplementary Development Contribution Scheme.**

- 7.1. The Supplementary Development Contribution shall be reviewed as part of the review of the Development Contribution Scheme and incorporated into the new Development Contribution Scheme made under Section 48 of the Planning & Development Acts 2000-2006.

**8. Format of the Development Contribution Scheme.**

The Supplementary Development Contribution Scheme is structured as follows:-

1. Schedule 1 the amount of contribution payable under the sewerage services category and the basis for the determination of the amount of contribution for new sewerage services provided or to be provided under different water services programmes.
2. Schedule 2 Serviced Land Initiatives which apply to individual water and sewerage projects in particular towns & villages.

Column 1 of each schedule indicates the particular infrastructure project, Column 2 of each Schedule indicates the category of contribution, Column 3 of each Schedule indicates the amount of contribution payable under the each category and in Column 4 the basis for the determination of the amount of contribution.

For the avoidance of doubt the following shall apply:

- (i) the supplementary development contribution shall be in addition to any contribution payable under the Development Contribution Scheme 2004 for existing services facilitating the development,
- (ii) the various categories of contribution are applied to a particular planning application **only** where they are relevant.
- (ii) The contribution indicated in the Serviced Land Initiative shall be in addition to that required under Schedule 1.
