SPECIAL SPEED LIMIT (Housing Estates) BYELAWS 2017**

Notice is hereby given in accordance with Section 9 (4) of the Road Traffic Act, 2004, that Mayo County Council proposes to introduce Bye-Laws, which shall be known as the Mayo County Council Special Speed Limit (Housing Estates) Bye-laws 2017, in relation to the reduction of Speed Limits in Housing Estates to 30 Km per Hour on the public roads within the Housing Estates specified in the Schedules listed below :
