NOTICE****STRATEGIC ENVIRONMENTAL
ASSESSMENT OF THE
REGIONAL WASTE

Notice is hereby given by the Lead Authorities for the three Waste Regions in Ireland that Screening for Strategic Environmental Assessment (SEA) in accordance with S.I. 435 of 2004 (as amended) has been undertaken on the draft Regional Waste Management Plans and it has been determined that SEA is required for each of the three plans. A copy of the Screening Statement is available for inspection on the relevant websites below.

SEA Scoping for the environmental assessment has now commenced and a period of public consultation on the scope of the SEA is now open. A copy of the draft Scoping Reports are also available for inspection on the relevant websites below. Written submissions are sought from interested parties wishing to comment on the SEA scope. All submissions made will be given due consideration in advance of the environmental assessment of the plans.

Written submissions in relation to the scope of the Environmental Report for the three draft Regional Waste Management Plans, with respect to the administrative areas of the Local Authorities, may be made in writing or by email to the appropriate address shown below by close of business on or before Friday 4th July 2014.
