#### Covid-19

The Global Pandemic – Covid-19 had brought about unprecedented changes to society and to this Council. We have responded and adapted the way in which we deliver our services to the citizens of this County.

I would like to put on record my thanks to the Management Team and the entire staff of this Council for their efforts in responding and adapting, over a short period of time, to the enormous challenges posed by the pandemic, which ensured that we continued to deliver essential services to the our citizens. Measures taken include:

- Introduction of Remote working
- Making available facility and staff for Contract Tracing Centre on campus at Áras an Chontae
- Setting up of Community Response Forum and the provision of a dedicated telephone helpline.
- Deployment of Civil Defence team to support communities and the voluntary sector
- Working with the HSE and An Garda Siochana on an inter agency basis to assist in compliance with public health guidance in limiting the spread of the pandemic.
- Introduction, processing and payment of Restart Grant for businesses.

I would also like to acknowledge the support and forbearance of the elected Members as we have adapted in response to CoVid-19.

As we progress through the Government's Roadmap for Reopening Society and Business there will be further adjustments to be made to our work practices and to our workplaces to adapt to a new way of doing business and the delivery of services.

The financial impact of the pandemic cannot be overcome by ourselves alone and I continue to make the case at National level for the need for a support package for Local Authorities which will enable us to continue to deliver our services in an environment of significant pressures on our local income sources.

#### **Emergency Services:**

#### **Crossmolina Fire Station**

Tenders have been sought for the construction of a new purpose built fire station together with a drill tower, drill yard and parking area with a closing date of the 8<sup>th</sup> July for receipt of same.

#### **Emergency First Responders**

Emergency First Responder training was held recently with the first ever qualification of 32 firefighters as Emergency First Responders.

#### **Health and Safety**

Fire Service have had their Safety Management successfully approved by the National Standards Authority of Ireland for migration to the international occupational Health and Safety Standard ISO 45001

#### **Mayo Civil Defence**

Civil Defence in Mayo provide support to the Emergency Service Agencies during times of Emergency. An integral part of our service is to support our communities, never has this been more important than during the COVID 19 Emergency. We have undertaken 59 missions to support our community equating to 468 Volunteer hours.

Our emergency response capability is maintained at all times to enable us to assist in any unexpected event that might occur. In recent times we have responded to Primary Response Agency requests to assist with missing person searches.

Civil Defence provided logistical support to the State Funeral of Detective Garda Colm Horkan in Charlestown at the request of An Garda Siochana.

The announcement that the Civil Defence Unit in Mayo will receive a new Ford Ranger 4WD Vehicle from the Department of Defence to enhance its vehicle fleet and response capability is welcomed.

Mayo has been awarded 11 Blue Flags and 6 Green Coast Awards for the 2020 season. This year Bertra Beach got its Blue Flag status back - one of only 3 to do so nationally. The Blue Flag Beaches awarded for Mayo are: Carrowmore, Bertra, Clare Island, Mulranny, Dooega, Keem, Keel, Dugort, Mulaghroe, Elly Bay and Ross. The Green Coast Beaches are: Portacloy, Rinroe, Cross, Srah, Termon and Tranaun.

#### Puppy Check List – Getting a new dog

The Dog Warden service have received an increased number of calls in recent weeks from the public enquiring about getting a new dog or puppy. The Dog Warden asked potential dog owners to give careful consideration before getting a new dog/puppy. She shared advice and posted a "Puppy Checklist" from the Irish Pet Advertising Advisory Group to assist individuals if getting a puppy..

#### Be a responsible Dog owner during lockdown

Mayo County Council, alongside the Dog Warden, are calling on the public to be responsible dog owners during the current COVID-19 restrictions.

"keep your family safe and be considerate of others when out walking or running and keep your dog on a lead".

All dog owners should plan and keep their walks within the distance, as outlined in public guidelines, and ensure dogs cannot leave owners garden or property while owners are at home.

"Mayo County Dog Warden, Laura Mulligan, said; "During the COVID-19 restrictions we are recommending that all dog owners keep their dogs on a lead when out walking for their own safety and the safety of others. If your dog is off lead, it is more difficult to keep the 2-meter social distance. Remember to practice physical distancing of two metres and if you're unwell, please stay at home. Stay Safe, Stay Strong, Stay Separate."

#### Housing

Housing Construction/Acquisition Programme 2016-2021

• Rebuilding Ireland target for Social Housing in Mayo is 708 however County Council will endeavour to exceed this figure.

Progress on 2016-2021 programme is as follows:

430 units have been completed with another 293 in different stages of progress.

#### HAP and RAS

In June 2020 the following was delivered;

• 17 houses delivered under the HAP scheme

This gives a total of 2,133 households supported by RAS and HAP in Mayo. (1,324 HAP; 809 RAS)

#### Leasing

In June 2020 under the leasing programme the following were deliver:

- 6 houses under STL.
- 1 house under RLS

This give a total of 218 households supported under the Leasing Programme in Mayo.

#### **Refugee Resettlement**

167 persons accommodated in Mayo to date (151 Mayo County Council and 16 persons accommodated by the Red Cross in pledged accommodation)

#### Homelessness

There were 7 presentations in June and 42 presentations in total for 2020.

#### **Architectural Services**

Architects have been successful in securing the following RRDF Cat 2 funding:

- Newport Regeneration Project €355K.
- Ballyhaunis Community Vision €168K.

Conservation Architect has been successful in securing funding through the Historic Structures fund as follows:

- St. Catherine's Church Louisburgh €18K.
- Holy Trinity Church, Westport €50K.

A full design team have been engaged to deliver the RRDF Ballina Innovation Quarter, with an anticipated pre-Christmas tender date.

• The community section has led a strategic partnership with local development and community organisations to provide a targeted response to challenges presented by Covid-19. There has been a significant workload dealing with **Covid-19 Community Helpline**, **Covid Community Response Funding**, sectoral supports and advice on restarts.

- Responsive development and virtual delivery of adapted programmes:
  - o Creative Ireland Cruinniú na nÓg via Creative Mayo
  - National Be Active Day, online sports programmes for people of all ages and abilities
  - PPN documenting the community response to Covid in short films by Henry McGlade
- Two recent publications:
  - The Arts Services of Mayo (lead partner), Donegal and South Dublin County Council & The Arts Council produced: 'Working in Intercultural Contexts: A Guide for Local Authorities and Cultural Providers'.
  - Mayo County Council & DRCD produced: 'Celebrating Diversity: Our future together, a report from the Ballyhaunis Integration Seminar 2019.'

#### **Enterprise & Investment Unit**

Local Enterprise Office Mayo has delivered a range of essential supports to the small business community in Mayo. Key metrics include:

- **42 training programmes** and workshops took place over the last two months. **364 Business Continuity Vouchers** were received and processed, with a value of c.€400,000
- A LEO Evaluation & Approvals Committee took place on 25<sup>th</sup> June with 4 projects supported, with a cumulative value of €157,000
- The second round of funding for the Trading Online Voucher scheme was announced, bringing total grants approved for Mayo businesses to 107, with a value of €242,000

Funding of €300,000 announced to support enterprise hubs re-open along the Atlantic Economic Corridor as part of the Atlantic Economic Corridor Enterprise Hub Network Project. Funding of up to €5,000 will be provided in grant aid to successful applicants and will be delivered through Mayo County Council's Atlantic Economic Corridor Office.
